#### CALL TO ORDER.

Chairman McQUEEN called the meeting noted above to order at 9:00 a.m. in the Council Chambers at City Hall, 251 E. Honolulu, Lindsay, California.

#### APPROVAL OF SEPT. 23, 2015 MEETING MINUTES.

Chairman McQueen: Board members, you have reviewed the minutes of the Sept. 23, 2015 meeting, do I hear a motion to approve?

#### **ACTION:**

On Motion by SCHIMELPFENING and Second by ZIGLER, Minutes were approved as presented.

#### APPROVAL OF RECOGNIZED OBLIGATION PAYMENT SCHEDULE (ROPS).

Interim City Manager/Board member Bill Zigler introduced this item. He advised the Board that the Finance Director Tamara Laken had retired and he would be reporting on this item. He added she came in and wrapped this item up on her off time and reported that this is a request for approval of the ROPS Schedule and is pretty much the same as those submitted in the past with the exception that this request will cover the period of July 1, 2016 through June 30, 2017 which deviates from the previous reporting period of about 6-months. With this reporting period extended, the frequency of the board meetings will probably also change unless there are other pressing items requiring the need for a meeting.

He added that there were some needed changes on the resolution provided for today's meeting. He requested that the resolution be amended to reflect that the "Successor Agency will review the Recognized Obligation Payment Schedule on January 26, 2016 in support of adopting the ROPS for the period July 1, 2016 through June 30, 2017" and add "contingent upon approval of the Successor Agency" to the last paragraph of the resolution. He explained that the Successor Agency has not yet reviewed the ROPS and will do so at their regular meeting scheduled for January 26th. So obviously of the Successor Agency doesn't approve this we will need to reconvene again. I don't see that happening as there is nothing questionable here but if either agency don't approve the resolution we would need to come back and address it.

With no questions from the Board, Chairman McQueen asked for a motion to approve the Recognized Obligation Schedule.

#### **ACTION:**

On Motion by SCHIMELPFENING and Second by MARTINEZ, the Lindsay Oversight Board approved RESOLUTION OB16-01 ADOPTING THE RECOGNIZED OBLIGATION PAYMENT SCHEDULE FOR PERIOD JULY 1, 2016 THROUGH JUNE 30, 2017, AS AMENDED. Motion passed 4-0

#### **UPDATE ON FORMER RDA PROPERTIES.**

Interim City Manager/Board member Bill Zigler introduced this item. He reported that the State has now approved all RDA properties described in the report submitted to them including the triangle shaped property near the Main City Park and the area adjacent to the Olive Bowl. We went back to make sure there was nothing else required of the City and now have the green light to start selling properties. So, to kind of review the process

for you we told the State we would have the properties appraised; we did that, we said we would set the opening bid at the appraised value and hopefully drive it up from that and so the intent will be to publish it in the newspaper and put in on our website. We already have people reaching out to us on various properties. We will accept closed bids by a certain date, notify the winning bidder and have a requirement to provide \$2000 of earnest money then pay off the balance within say a couple of weeks. Once that happens the money will go to the County and the County will disperse them to the various agencies funds. We'll wrap that up as quickly as possible. I anticipate the Tivoli building to sell quickly, the vacant land between the R-N Market and NDS, the people who own NDS have been very interested in it, we have people interested in the Moore building we'll see if that pans out. We have also had people express interest in that large concrete area next to the Moore Building, which would also include our little Gallery Park.

Brief Committee discussion followed regarding persons interested in specific properties and concerns with their current condition.

Bill reported no interest has been expressed for the old Jessup property where the Coordinating Council is currently located and they have been informed that if the property is sold they may need to relocate. The State has authorized us to keep the Olive Bowl and that strip of land there by it. We had a community cleanup event there this past Saturday and people are already envisioning how to expand into that area. And we also have permission to keep the City Park and the triangle shaped property there by it. We can now focus on the sale of the properties previously described. Bill noted if the properties don't sell for the appraised value he didn't know exactly what the process will be, it strikes him that we could reduce it/them if everybody was in agreement or we can sit on them and wait for the market to improve. The City won't get anything out of this, but if say the Board started putting pressure on staff then we could try to work with the state and decide if we should reduce the prices. Bill said to feel free to call him if you have any questions or concerns.

Chairman McQUEEN asked if there were any further questions or discussion on this item. Hearing none and with no further business to discuss he asked for a Motion to Adjourn the meeting.

**ADJOURN**. Upon motion of ZIGLER, Second of MARTINEZ, Chairman McQUEEN, adjourned the meeting of the Lindsay Oversight Board at 9:45 a.m.
