## ORDINANCE NO. 532

A N ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LINDSAY AMENDING CHAPTER 5.04 OF THE LINDSAY MUNICIPAL CODE PERTAINING TO BUSINESS LICENSE VIOLATIONS.

## THE CITY COUNCIL OF THE CITY OF LINDSAY DOES ORDAIN AS FOLLOWS:

ARTICLE 1: Chapter 5.04 of the Lindsay Municipal Code shall be amended to read as follows:

ARTICLE 2:

Section 5.04.140 of the Lindsay Municipal Code shall be amended to read as

follows:

5.04.140 License - Delinquency penalty and collection

A. Delinquency. To all delinquent license taxes there shall be added a penalty of twenty-five percent of the amount of taxes due.

B. If the director determines that the nonpayment of any license tax due under this chapter is due to fraud, a penalty of twenty-five percent of the amount of the tax shall be added thereto in addition to the penalties stated in subsection A of this section.

C. Penalties Merged with Tax. Every penalty imposed under the provisions of this section shall become a part of the tax required in this chapter to be paid. (Ord 356 § 14, 1978)

D. The provisions in this section are in addition to and shall not limit the provisions of section 5.04.610.

ARTICLE 3: Section 5.04.610 of the Lindsay Municipal Code shall be added to Chapter 5.04 and shall read as follows:

5.04.610 Violations

Any person violating this chapter or any provisions thereof shall be guilty of a misdemeanor and, upon conviction thereof, shall be punished by a fine not exceeding one thousand dollars (\$1000.00) or by imprisonment for a term not exceeding six (6) months, or by both such fine and imprisonment. Each day that any provision of this chapter is violated is a separate and distinct offense and shall be punishable as a separate and distinct offense. Notwithstanding the classification of a violation of this chapter as a misdemeanor, at the time an action is commenced to enforce provisions of this chapter, the trial court, upon recommendation of the prosecuting attorney, may reduce the charged offense from a misdemeanor to an infraction. Any person convicted of an infraction under this chapter shall be punished by:

- A. A fine not exceeding fifty dollars (\$50.00) for a first violation;
- B. A fine not exceeding one hundred dollars (\$100.00) for a second violation of this article within one year; and
- C. A fine not exceeding two hundred fifty dollars (\$250.00) for each additional violation of this article within one year.

ARTICLE 4: The City Council declares that this ordinance is exempt from the California Environmental Quality Act (CEQA) because it is not a project pursuant to Section 15378 of the CEQA Guidelines.

ARTICLE 5: This ordinance shall be in full force and effect on or after the 30<sup>th</sup> day after its adoption by the City Council. Within 15 days after its adoption by the City Council, this Ordinance shall be published in full text or in summary in a newspaper of general circulation in the City of Lindsay.

The foregoing ordinance, read by title only with waiving of the reading in full was introduced at a regularly scheduled meeting on the  $11^{th}$  day of October, 2011.
